




Herbicide Applicator Investigation **by Sheila Rappazzo**

In order to provide assurance that the cost to treat the Lake with herbicide is competitive, we sought proposals from companies that have provided this service in other lakes in New York. In addition to Aquatic Controls Technology, which provided the treatment this past year, proposals were requested from Allied Biological and Lycott Environmental. These two companies' names were provided to us by DEC in Warrensburg as large companies that have provided chemical treatment to lakes in this region. Lycott is the provider that was used

for chemical applications for Cossayuna in the past for numerous years. Allied Biological's proposal was considerably more than the other companies, and set out a range of cost for the treatment that would be dependent on whether the treatment areas were contiguous large blocks or smaller areas. But even at the lower end of the range, their proposal for 40 acres was several thousand dollars more, and for treatment of 120 acres, was more than \$10,000 greater than the other two companies. Lycott's proposal was relatively close to the costs for treatment by

Aquatic Controls. Lycott's proposal excluded costs for pre and post treatment surveys, water sampling, and reporting. So for comparison purposes excluding those costs from the Aquatic Controls costs, results in, for treatment of 40 acres Lycott being about \$1000 less, and for treatment of 120 acres Lycott being a few thousand dollars more than Aquatic Control. Given the very successful treatment by Aquatic Controls Technology this past year and that there does not appear to be an economic advantage in changing providers, we

recommend continuing with Aquatic Controls for chemical treatment of the Lake for the 2014 season.

The Board of Directors approved via an on-line vote and we will soon be entering into contract with Aquatic Control.

with the towns and county to reduce nutrients from coming into the lake through streams, culverts, road run-off and septic systems. Part of this effort will be the development of grant applications which involves a lot of data collection.





Harvesting Program by Ron Remillard

It's that time of year again when we should start to think of 2014 harvesting. I know it's hard to think about harvesting with the snow, ice and cold, but this is when we start our planning. The program will begin at the end of May, 2014 – maybe even before some summer residents have begun to make their trek back to the Lake.

The Harvesting Program on Cossayuna Lake proved itself very well in 2013. The South end was opened up allowing motorists and fishermen alike to use these waters. Shorelines and open waters were clearer than ever before. We believe the lake was in the best of shape due to the combined efforts of the Chemical Program and

the Harvesting Program. However, harvesting is still a necessary and important method of weed removal. Frank Gabianelli did an excellent job of keeping the machine going despite several repairs. He also did a great job keeping parts on hand for when there was an emergency.

Throughout the spring and summer our full time

workers removed more than 350 loads of weeds.

Please be reminded that participation in the Chemical program does not automatically put you in the Harvesting program. Therefore, to continue keeping the lake looking good, we would hope to see the same combined participation for 2014. Applications will be forthcoming.

Blue Green Algae Alert From DEC by Pat Smith

In September, samples of blue green algae from Cossayuna Lake were submitted to DEC for testing. The DEC has cautioned lake users to avoid direct exposure to this algae due to its potential for toxins, and to seek medical assistance as needed. There is public

Cossayuna Lake Improvement Association, Inc Minutes of the Election Meeting 24 August 2013

Present: R. Hutchinson, R. Remillard, F. Gabianelli, P. Smith, L. Varney, E. Mussi, N. Hieber, L. Wilbur, J. Romano, G. Henry, F. Smith, and L. Lant Membership quorum met.

Call to order: President Pat Smith called the meeting to order at 10:04 AM and established a quorum. She thanked everyone for their support of the CLIA throughout the year.

Minutes: The minutes of the General Meeting held on June 9, 2013 were handed out. Motion to accept made by J. Romano second by L. Wilbur. The motion carried.

Treasurer's Report: R. Hutchinson presented the Treasurer's Report dated 8/15/13 and stated that there is a Harvesting account balance of \$62,145.80 and a General Account balance of \$58,883.96 for total accumulated funds of \$121,029.76. He stated that we have one liability of \$36,000.00 in the mortgage on the harvesting equipment. Motion to accept the treasurer's report as written made by A. Grignon; second by B. Grignon. The motion carried.

Membership: N. Hieber reported that we had 248 members for 2013 which represents 216 households.

Buildings & Grounds: Joe Romano reported that Alan Lant fixed the roof leak and did not want to be compensated because of all of the help with Pennies for Peyton.

By-Laws - In the absence of K. Pauley, chair, Pat reported that there are no changes to the by-laws.

Promotionals: L. Lant reported there are still some long sleeves shirts are available for purchase.

Social: Joe Romano has volunteered to take over as Social Chair. He reported that Bob Montayne's Clam Bake & BBQ went extremely well. Next year he will try to get more vendors involved since there was such a positive vibe at this past one. Friday Night dinners were successful.

There will be a Volunteer Appreciation Night, potluck, all is invited. September 14th at 6 pm. Please let Pat know in advance if you plan on coming.

Election: P. Smith appointed two members as election tellers. Since the slate of officers was incomplete, two members volunteered to serve: Margo Mensing from North End of the lake and Larry Varney, who used to be on the board. Ballots were cast and collected for count. The following candidates were elected: Pat Smith - President; Kelly Pauley – Vice President; Richard Hutchinson – Treasurer and Elisa Mussi – Secretary. The directors will be Frank Gabianelli – 3 yr term; Mike Mound – 3 year term; Sheila Rappazzo – 3 year term; Jerry Simon – 2 year term; Larry Varney – 2 year term and Margo Mensing for a 1 year term.

Lake Management: Lynn Wilbur reported the positive changes in the lake. The Water is low (due to no rain). The dam will be opened right after the Columbus Day weekend.

Jeff Madison discussed the excellent control over the milfoil and it's the best year of water clarity in years.

Frank Musso commented about the decline in zebra mussels around.

Plan for next year: another treatment, keep up with harvesting program and get more funds to keep it all going.

Weed awareness: hydrilla. Very dangerous to lakes. Make sure all boats are clean when going from one body of water to next.

If any blooms are spotted (slimy green globules) please report to Lynn Wilbur so DEC can be told.

Bob Baldwin voiced concern about the increase in Water Chestnut sightings. In past he and another would pull by hand but now needs to be dealt with. (possibility of having Boy Scouts come and pull for merit badges)
Septic systems around the lake is another concern. Tests should be done but CLIA cannot enforce it. It's a town/county issue and health department.

Community needs to be educated about bank erosion, permitting bank stabilization and suitable septic systems. Much discussion about water run off from farms, phosphorous and keeping lawns clean so they don't pollute the lake.

Kate reported that with the help of Nancy, Lynn and Wendy; the Neighbor to Neighbor Program really worked with getting funding and participation with the chemical funds.

Harvesting: R. Remillard reported that the new GPS has helped immensely by identifying heavy weed beds and where they left off after a load of weeds were dumped. With the help of the chemical application, there is a significant decrease in weed loads taken out. Frank G. reported that the 3rd cutting is almost done. Luckily the curly leaf pond weed was cut before it could go to seed and milfoil did shoot up in untreated areas because of the low water and hot temperatures.

A. Grignon thanked the Lake Management Team for their efforts making it a great swimming year!

NEW BUSINESS:

New lake management methods are being researched: aeration. There will be a presentation done by John Tucci from Lake Savers, on September 14th at 10am. Discussion went on about how it has worked in other lakes. Many members asked question. Our research teams (CLSAP team and Aeration team) will continue to find the pros and cons of this technology.

Frank Smith brought up the possibility of reintroducing walleye into the lake. Discussion took place since it is only in research mode and the lake is a long way from being able to take that on. J. Simon commented that this lake is a bass fishing lake and that he believes that there will not be an increase in traffic for fishing walleye. He said that just because the Sportsman Club has 4500 members that that does not mean that 4500 of them are fishermen. They do lots of other activities. He stated that, after observing for many years, the majority of the boat traffic on the lake is recreational; not fishermen. The tournaments are for the bass/pike/tiger musky.

Aeration questions about water being silt-y from B. Grignon. Questions about introducing more fish, will it make for more traffic? Discussion ceased.

Motion for Lake Management to keep researching new methods: Maryanne Lettuce 1st, Bob Baldwin 2nd. Motion carried.

FOLA conference will be attended by L. Wilbur and one more board member plus 2 CLIA members.

Adjournment: Motion to adjourn made by L. Wilbur; second by B. Grignon. The meeting adjourned at 11:22 AM.
