ARTICLE III

Membership and Board of Directors and Officers

Current - Membership: Membership in the Corporation is open to the people who reside within the confines of the tract known as Cossayuna Lake, which includes the area from the shore of the lake up to **any** including any point within one mile from the road that encircles the Lake.

Proposed - Membership: Membership in the Corporation is open to the people who reside within the confines of the tract known as Cossayuna Lake, which includes the area from the shore of the lake up to **and** including any point within one mile from the road that encircles the Lake.

ARTICLE III

Membership and Board of Directors and Officers

Directors: Deleting each duplicated statement below

- Each Director will have one vote. In the event that a Director is not able to be present at the meeting, the Director may be represented by written proxy.
- The Board of Directors may make such rules and regulations, as it deems necessary to the conduct of its meetings.

ARTICLE III

Membership and Board of Directors and Officers

Current - Officers: The President of the Corporation will preside over all membership meetings and will be responsible for the management of the Corporation's business. The President will carry out the orders and resolutions of the Board and will have the authority to reasonably delegate responsibility to others. The President may be one of the officers required to sign checks and drafts for the Corporation. The Treasurer will make a report at the General Meeting of the Corporation relative to the financial affairs of the Corporation. The Treasurer will be bonded as required by the Board and will perform other duties as may be assigned by the Board. The Treasurer will be required to sign all checks for the Corporation. All Corporation funds will be deposited to the credit of the Corporation in the financial institution approved by the Board.

Proposed - Officers: The Treasurer and Assistant Treasurer will be responsible for the financial affairs of the Corporation. The Treasurer and Assistant Treasurer will receive funds paid to the Corporation and pay all bills incurred by the Corporation as authorized by the Board. The Treasurer or Assistant Treasurer will make a report at the General Meeting of the Corporation relative to the financial affairs of the Corporation. The Treasurer and Assistant Treasurer will be bonded as required by the Board and will perform other duties as may be assigned by the Board. The Treasurer or Assistant Treasurer will be required to sign all checks for the Corporation. All Corporation funds will be deposited to the credit of the Corporation in the financial institution approved by the Board.

ARTICLE III

Membership and Board of Directors and Officers

ARTICLE XI

By-Laws

Deleting this Article, duplicated within Article XVIII Modification of Articles of Incorporation and By-Laws

The By-Laws may be revised, amended, or appealed after written notice to the membership. By-Law changes require an affirmative vote of not less than 2/3 of the members present and voting.

ARTICLE XIV

Maintenance of Separate Books and Records

Current - The Corporation shall maintain separate accounting books, records, ledgers and checking/savings accounts distinct from its operating account or as recommended by its Certified Public Accountant.

Proposed - The Corporation may maintain separate accounting books, records, ledgers and checking/savings accounts distinct from its operating account following recommendations of its Certified Public Accountant and Finance Committee, upon approval of the Board of Directors.

Cossayuna Lake Improvement Association, Inc. Lake Management Plan 2011 Season

Dear Members.

To maintain compliance with the By-Laws, the information below is being posted in the newsletter. In order to implement the recommended changes shown below, a majority of the members voting at the August meeting must vote to accept the drafted changes presented by the Board of Directors in order for them to be adopted.

To maintain the water level 6 inches above the bottom of the spillway

- Begin winter draw down the day after Columbus Day by removing the board from the spillway and slowly drawing down the lake through October and completely opening the gates on the spillway by November 30, 2010.
- Begin monitoring the water level in the spring as soon as the ice goes out.
- Establish the summer level at 6 inches above the bottom of the spillway as soon as possible.
- Maintain the summer level at 6 inches above the bottom of the spillway, weather permitting.

To maintain the water quality in Cossayuna Lake at a level which supports such activities as fishing, swimming, and boating in the lake area by use of mechanical control methods.

Chemicals:

• Suspend the chemical program during the year 2011 after which time the board of directors will evaluate the results of this action.

Harvesting:

- Run the harvesting program from mid May until the beginning of September with a paid work crew, depending upon funds available.
- Seek funding from the towns, county and state and other sources to support the harvesting program.
- Offer harvesting as an every time option to all members who donate to the program.
- The specific plan to meet the harvesting objectives will be approved by the Board and submitted to DEC for approval.

Biological Control:

 Continue to investigate the possibility of introducing weevils into Cossayuna Lake to control purple loosestrife and Eurasian Milfoil

To minimize the introduction of nutrients and sediment into the lake by careful monitoring of the tributaries and the shorelines.

- Continue to work with various highway departments and the county soil and water commission and DEC to encourage the best practices in culvert replacement and road repairs.
- Continue to monitor the environment to ensure that building codes and sewer discharge regulations are observed

To monitor the water quality through research activities designed to assess such factors as lake usage, water clarity, oxygen saturation, and bacterial contamination.

- Test areas of concern for nitrates, phosphates, and bacterial contamination
- Offer a voluntary septic testing program
- Continue the CSLAP membership and water sampling

To educate individuals within the lake's watershed in effective management techniques.

- Provide homeowners with education on bank erosion
- Provide information on permits needed for bank stabilization
- Provide education on lake management to the Town Boards
- Provide homeowners education on septic systems

Results of the Jerry Simon Memorial Fishing Tournament

This event was held on July 10th and had 26 fishermen in the adult category and 2 fishermen in the youth category. The weather didn't cooperate for the first two hours of the tournament with heavy rain falling. Despite the bad weather, 17 fishermen weighed in their catches at the CLIA docks. Mike Ellrott, a lake resident and member of the Albany

Bass Masters, conducted the weigh-in with help from Jerry LeBlanc and Danny Paul. The winner in the youth category was Luigi Cubello with 7.07 lbs of fish. The adult category winners were: 1st place -Dan Rokjer with 17.64 lbs; 2nd place - John Yetto with 13.58 lbs; 3rd place -Andrew Marchland with 11.60 lbs; 4th place – Dan Sartell with 9.61 lbs; and

5th place - Dan Chambers with 8.51 lbs. The "lunker pool" was won by Andrew Marchland with a bass weighing 5.75 lbs. Congratulations to all! The CLIA would like to thank Jerry Simon, Sr. for organizing the tournament. Half of the money collected in tournament registration was awarded in prize money and the remaining half was given to the CLIA.

Cossayuna Lake Improvement Association Minutes of the General Meeting July 23, 2010

Present: A. Grignon, W. Grignon, N. Hieber, R. Hutchinson, N. Jepson, L. Lant, E. LeBlanc, P. Moore, K. Pauley, D. Rokjer, M. Rokjer

Acting President P. Moore called the meeting to order at 10:10 a.m.

Minutes: The minutes of the August 29, 2009 meeting were reviewed. C. Rappazzo made the motion to accept the minutes. L. Varney seconded. They were unanimously approved.

Treasurer's Report: R. Hutchinson gave an overview of the responsibilities of the treasurer and the assistant treasurer. He indicated that the CLIA has two accounts-the General account and the Harvesting account. The Harvesting Account collects fees for services rendered. The General Fund obtains revenue from membership fees, promotional sales, rentals, and social events. This fund functions from the support of membership and the community. The General Fund also supports the expenses for the building and the grounds.

General fund \$47,586.40 Spillway Account 2,851.00

Harvesting Account \$45,738.88

\$48,631.04 remains to be paid on the mortgage held on the harvesting equipment purchased in 2005.

R. Kahn asked if we should consider paying down the mortgage with money from the CD. R. Hutchinson indicated that the CD funds are needed in case of a major repair or replacement of any of the equipment. Not for profit organizations have difficulty borrowing funds.

Rentals: E. LeBlanc indicated that we have six rentals for the 2010 season. She indicated that some people thought the increase of the rental to \$100 was excessive. R. Hutchinson made the motion to decrease the rental to \$75 for members and keep the amount of \$125 for non members. B. Grignon seconded. It was unanimously approved.

Membership: N. Hieber indicated that there are 219 members to date and there were 239 members last year.

Education: P. Moore stated that 16 people participated in the boater's safety course in June.

Newsletter/Public Relations: K. Pauley indicated that we currently send email information to 200 email addresses. The newsletter is sent to 500 community wide individuals. She stated that the next newsletter will be sent out at the end of July. It will include the proposed changes in the Lake Management Plan and the proposed changes to the By-Laws. These items need to be voted on at the August Election Meeting. She indicated that she is trying to refine the membership form to include summer and winter addresses.

K. Pauley stated that there were 95 photos submitted for the photo contest. Members were asked to vote for their favorite photos. The winner will be announced at the last Doo-Wop on August 27th. She also indicated that the tote bag raffle will be announced at this event as well.

Building and Grounds: B. Grignon stated that the new windows were installed in the spring and thanked all the individuals who helped install the windows. There were also renovations made to the building that was donated by a member. He thanked the 40 people who volunteered for the spring clean up. He also thanked T. Schultz for mowing the lawns throughout the season. He stated that C. Rappazzo and he will be installing a new electrical panel for just the hot water heater and the water pump. This will avoid the possibility of people shutting off the wrong switches. He stated that the fall closure of the building will be held Saturday, October 9 and the rain date will be October 10. B. Gifford indicated that there should be a list of things to switch on and off. B. Grignon indicated that there is a list.

Social: A. Grignon stated that the Doo Wops started on July 9 and will continue each Friday night through August 27. The first dance, LuLu and the Shoemakers, was a success. There is also a dance scheduled for July 24, an Open Mic Nite scheduled on August 28 and a DJ scheduled for September 4.

Lake Management: D. Rokjer stated that there have been three complete rounds of cutting around the lake. He said that 1.2 million lbs. of weeds were removed to date. The paddle wheel motors on the harvester needs to be replaced. He stated that the new harvester has been in operation for six years. C. Rappazzo asked how many people participate in the harvesting program. D. Rokjer stated that there are 126 participants.

M. Ellrott asked what effect the lack of chemicals has had on the lake. D. Rokjer indicated that with the increased harvesting he feels that the clarity of the lake water has improved. P. Moore stated that the board recommended the suspension of the chemicals for an additional year. B. Baldwin indicated that DEC removed the lake from its Priority List of Impaired Waters. D. Rokjer stated that the DEC is getting the phosphorus reading numbers from our CSLAP testing. L. Varney stated that new housing construction on the lake needs to have approved septic systems from the county. S. Rappazzo inquired about the DEC plan, or lack thereof, to warrant the removal from the list.

Nominations: P. Moore indicated that there is not a full slate of candidates to fill the needed vacancies. There was a request for nominations from the floor. The following people were nominated: L. Varney, M. Mound, F. Gabianelli, and C. Stanford-Smith. R. Kahn made the motion to accept the nominations. It was seconded by H. Emmert.

New Business: R. Kahn requested that the first General Meeting be held in June so that more input could be obtained from the community before the season begins. C. Rappazzo seconded. It was unanimously approved.

- C. Rappazzo inquired about the spillway repairs. D. Rokjer stated that DEC indicated major repairs to the spillway require an engineer plan. He did state that DEC was willing to accept a sketch for minor repairs. D. Rokjer submitted the sketch to DEC.
- M. Ellrott asked about the fishing tournament. D. Rokjer indicated that there were 28 participants and it generated \$300 in revenue for the lake.
- L. Varney made the motion to adjourn the meeting at 11:40 a.m. K. Pauley seconded.

Community Support Keeps Things Running Smooth

The CLIA would like to extend our gratitude for all of the support we receive year after year.

In addition to the support received via ongoing membership support, the CLIA is very fortunate to receive donations from many residents. The donations are utilized to support the Harvesting Program.

Expenditures in the Harvesting Program include the wages for two full time employees, who work for 3 ½ months, and the associated costs such as Unemployment Insurance, Workman's Compensation and Disability Ins. In addition, there is ongoing maintenance and insurance on both the truck and the harvester equipment. The program is designed so there is enough income to cover all planned expenses for the standard three trips

around the lake. The program also allows for a small amount to be saved towards the purchase of the next harvester purchase, in approximately 10 years.

Donations submitted to the harvesting program allow the harvester to perform end of season open water cutting and assist with the cost of large dollar repairs. Your generous donations have allowed the Harvesting Program to exceed its goals.

Another valued form of support received is time. No value can be placed on the time and energy that individuals have devoted to the Social, Fund Raising and Community
Awareness programs.

The CLIA would like to extend gratitude to some special individuals that have devoted much time and energy to The Association and to The Board over the years.

The Hopkins family faithfully hosted events such as the Chicken Barbeque, the Prime Rib Dinner and the Clam Steams over the years. They were favored events of many and very successful in bringing neighbors together.

Harvesting Program

The harvesting program was started in mid May at the NYS boat launch. The harvester then moved on to do the open waters in each township to fulfill the contracts. Individual customers were started the beginning of June. We have completed 3 cycles around the lake to date and have removed over 1 million

pounds of weeds. The harvester driver spent 4 days picking up 14 loads (100,000 lbs) of the "islands" of filamentous algae floating down the lake. There are 126 customers in the program this year.

This is the sixth year of operating the "new" harvester and it's

getting apparent that the paddle wheel motors are getting tired. We intend to replace them at the end of the season at a cost of approximately \$4,000. We purchased a 1988 International Harvester truck with a diesel engine with 29,000 original miles and a brand new dump box for \$12,900. The money to

purchase the truck was taken out of the H.E.R.F. (Harvesting Equipment Replacement Fund) account.
