Boating Safety

Spring has arrived! And with that comes warmer air temperatures, sunshine, and you are ready to get out onto the water. But are you really ready? First let's talk about safety. From November 1st through May 1st, all boaters and passengers in watercraft less than 21 feet in length must be wearing a lifejacket. This includes kayaks & canoes. Children under the age of 12 and on a watercraft of less than 65 feet in length must wear a lifejacket year-round.

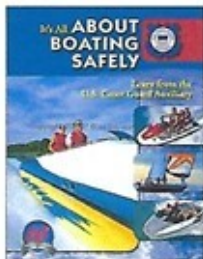
Research from the U.S. Coast Guard revealed that in 2018 there were 4,145 boating accidents that resulted in 633 deaths. Of the 633 deaths, 77% were a result of drowning in which 84% of the victims were **NOT WEARING LIFEJACKETS** at the time. Further investigation into these incidents found that 74% of the people involved had **NO BOATER SAFETY** instruction at all.

So, the next time Law Enforcement, DEC, Fire Department or Coast Guard is checking your vessel for proper safety equipment or to ensure safe and sober operation, please remember one thing. We are not out to issue tickets or give you a hard time; we are trying to save lives. Have a happy and safe 2020 boating season.

Public Education Course Flyer: About Boating Safely



If you are interested in an exciting, in-depth boating safety course, check out the in classroom (seminar) version of our popular online boating course.

This beginner boating class will give you the knowledge needed to obtain a boat license or safety certification in many states. Many boat insurance companies will offer discounts on boating insurance to boaters who successfully complete *About Boating Safely*.

TOPICS INCLUDE:

Introduction to Boating - Types of power boats; sailboats; outboards; paddle boats; houseboats; different uses of boats; various power boating engines; jet drives; family boating basics.

Boating Law - Boat registration; boating regulation; hull identification number; required boat safety equipment; operating safely and reporting accidents; protecting the marine environment; Federal boat law; state boating laws; personal watercraft requirements.

Boat Safety Equipment - Personal flotation devices ("life jackets"); fire extinguishers; sound-producing devices; visual-distress signals; dock lines and rope; first aid kit; anchors and anchor lines; other boating safety equipment. *About Boating Safely*

Safe Boating - Bow riding; alcohol and drug abuse; entering, loading, and trimming a boat; fueling portable and permanent tanks; steering with a tiller and a wheel; docking, undocking and mooring; knots; filing a float plan; checking equipment, fuel, weather and tides; using charts; choosing and using an anchor; safe PWC handling; general water safety.

Navigation - The U.S. Aids to Navigation system; types of buoys and beacons; navigation rules (sometimes referred to as right-of-way rules); avoiding collisions; sound signals; PWC "tunnel vision."

Boating Problems - Hypothermia; boating accidents and rescues; man overboard recovery; capsizing; running aground; river hazards; strainers; emergency radio calls; engine problems; equipment failures; carbon monoxide (CO); other boating and PWC problems.

Trailer, Storing and Protecting Your Boat - Types of trailers; trailer brakes, lights, hitches, tires, and bearings; loading, balancing, and towing a trailer; towing (and backing) a trailer; boat launching and retrieving; boat storage and theft protection; launching, retrieving and storing a PWC.

Hunting and Fishing, Water-skiing and River Boating - Carrying hunting gear and weapons in a boat; fishing from a boat; water-skiing safety guidelines and hand signals; water-skiing with a PWC; navigating rivers, and other boating tips.

2020 Herbicide Treatment Update

Sheila Rappazzo, Herbicide Chair

We have identified 120 acres of the lake that need treatment with herbicides this year. Of that total, 90 acres are targeted for the treatment of Curlyleaf Pondweed. After 2 years of not treating for Curlyleaf, last year it was back with a vengeance, with thick beds throughout the lake. The remaining approximately 30 acres is to keep the Milfoil in check. Last year's Milfoil treatment was very successful, but there are still some areas that were not treated last year that need treatment now.

The application for the permit for herbicide treatment was filed with DEC in February. We had hoped to use a different herbicide for the Curlyleaf Pondweed which is less expensive than the one we have used in the past. However, that herbicide will not be viable for our use at this point due to DEC regulations. We hope to get approval for the permit in very early May in order to treat prior to when the Curlyleaf seeds mature and drop.

The 120 acres that have been identified to be treated this year is a substantial acreage; we have not treated that much in several years. The cost is \$51,000 we have only collected \$7,990 so far. Your generous support for treatment of these non-native invasive weed beds is what has brought our lake back towards health. It is really important to be vigilant; if we don't keep it in check, the Milfoil will re-root all around the lake again, and as we've experienced, the Curlyleaf is quick to reemerge as well.

If we are not able to raise enough funds, we will be unable to treat all the non-native invasive weed beds that we have identified. Insufficient funding means more damaging weed beds will spread throughout the lake.

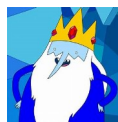


April 24th is national pigs-in-a-blanket day.

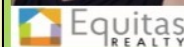
