Lake Management Appeal

Sheila Rappazzo, Lake Management Taskforce Chair

Please donate to support the Lake Management program for the treatment of invasive, non-native weeds. Part of life on our lovely lake is the yearly struggle to maintain water quality and overall health of the lake. We are grateful for both the generous donations we receive each year and for the efforts of dedicated volunteers who monitor water quality and levels, take water samples throughout the summer for testing, oversee the herbicide program and when necessary, get in the water and hand pull weeds. It is truly a labor of love, although the camaraderie and fellowship between this great group of folks are rewards in themselves.

Yearly herbicide treatment areas can range from 30 - 90 acres, based on what we find during our pre-treatment survey. We work with both our lake management service provider and the NYS Department of Environmental Conservation (DEC) to design and implement the appropriate treatment plan each year. Frankly, it's a lot of work and it is expensive, but the alternative is to see a serious decline in the quality of our lake environment.

Once again, we expect to target and treat Curlyleaf Pondweed and Eurasian Milfoil, the 2 most prominent of the invasive non-native weed species on our lake. Treatment will be completed early enough in the season so that it should prevent the seeds from maturing. However, we need to stay on top of the situation because regardless of the success of any one year of treatment, the plant seeds on the lakebed from prior years are still viable to grow.

We are also planning to include in our permit application to DEC some potential areas for treatment of Southern Naiad, in order to give us options if we again have a heavy overgrowth of this weed. While Southern Naiad is a native weed and generally considered healthy for the lake, a massive overgrowth like we experienced in some areas this past summer can be problematic, as many people around the lake know.

Your generous support for treatment of these non-native invasive weed beds is what has brought our lake back towards health. It is really important to be vigilant; if we don't keep it in check, the Milfoil will re-root all around the lake again, and as we've experienced, the Curlyleaf is also quick to re-emerge.

Early in the season we rebuilt the staircase leading down to the water, and thanks to Peter and Karyn Moore's generous donation, towed a second dock across the lake and installed it at the CLIA waterfront. At the end of the season, Association volunteers, coupled with a generous donation of staff, equipment and materials from Mark Masseo and Masseo Landscape Inc. did a great job to improve the shoreline. We replaced wooden fencing, cleared brush, re-graded the slope to the waterfront, installed perennial plants, mulched and seeded.

Our shoreline is ready for 2024 water fun. Stay tuned - next year we'll need ongoing support to keep our new landscaping weed free!

Thanks to everyone who helped raise funds, carried lots of stuff, pulled weeds, planted, provided water and snacks and generally supported our efforts. Job well done!

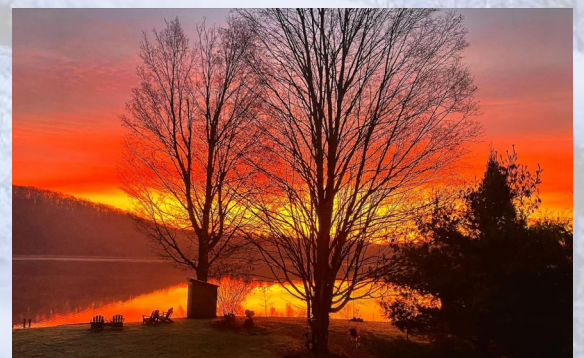

Proposed Changes to CLIA By-Laws

During the August 29th, 2023 CLIA Board of Directors Meeting, the Board approved the following additions to the By-Laws, subject to approval of the membership. A copy of the complete By-Laws document is located on www.cossayunalake.com/by-laws.

Proposed Addition to Article VI - Voting:

In the event the election for Officers and Directors is uncontested, the Secretary will cast a single ballot to confirm the election of the slate of candidates. If the Secretary is not present, the Chair of the Nominating Committee will cast the ballot. Any Absentee ballots received will not be recorded or archived.

Proposed Addition to Article XV – General Provisions:

Written Communication: As referenced in the By-Laws, Written Notices, Requests or Proxies shall include both physical and electronic forms of communication, including, but not limited to, postal delivery, website publication and electronic mail (email).

These changes will be submitted to the membership for approval and adoption at the 2024 Membership Meeting.

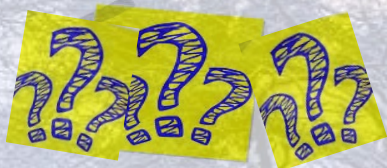

The Cossayuna Lake Improvement Association (CLIA) was formed in 1954 by a group of residents of the vicinity surrounding Cossayuna Lake. The first meeting was held on August 22nd of that year.



Officers were elected, committees appointed, and various matters were discussed concerning the good and welfare of the community. Subsequently, a constitution and by-laws were adopted, and the Association was incorporated.

The main purpose of the early organization was to encourage social life among its members, promote social activities among the younger members of the community, and to promote the health and general welfare, improvement and advancement of the community. As the organization matured, the CLIA took a leading role in organizing sustained efforts to monitor and maintain the health of the lake. These efforts take the form of fundraising for annual invasive, non-native weed remediation as well as volunteer efforts to monitor water quality throughout the busy summer season.

Cossayuna Lake covers approximately 776 acres, is 3 miles long with a 7/10 mile maximum width, 8.6 miles of shoreline and a maximum depth of about 29 ft.

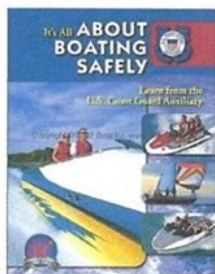

Public Education Course Flyer: About Boating Safely



If you are interested in an exciting, in-depth boating safety course, check out the in classroom (seminar) version of our popular online boating course.

This beginner boating class will give you the knowledge needed to obtain a boat license or safety certification in many states. Many boat insurance companies will offer discounts on boating insurance to boaters who successfully complete *About Boating Safely*.

TOPICS INCLUDE:

Introduction to Boating - Types of power boats; sailboats; outboards; paddle boats; houseboats; different uses of boats; various power boating engines; jet drives; family boating basics.

Boating Law - Boat registration; boating regulation; hull identification number; required boat safety equipment; operating safely and reporting accidents; protecting the marine environment; Federal boat law; state boating laws; personal watercraft requirements.

Boat Safety Equipment - Personal flotation devices ("life jackets"); fire extinguishers; sound-producing devices; visual-distress signals; dock lines and rope; first aid kit; anchors and anchor lines; other boating safety equipment. *About Boating Safely*

Safe Boating - Bow riding; alcohol and drug abuse; entering, loading, and trimming a boat; fueling portable and permanent tanks; steering with a tiller and a wheel; docking, undocking and mooring; knots; filing a float plan; checking equipment, fuel, weather and tides; using charts; choosing and using an anchor; safe PWC handling; general water safety.

Navigation - The U.S. Aids to Navigation system; types of buoys and beacons; navigation rules (sometimes referred to as right-of-way rules); avoiding collisions; sound signals; PWC "tunnel vision."

Boating Problems - Hypothermia; boating accidents and rescues; man overboard recovery; capsizing; running aground; river hazards; strainers; emergency radio calls; engine problems; equipment failures; carbon monoxide (CO); other boating and PWC problems.

Trailing, Storing and Protecting Your Boat - Types of trailers; trailer brakes, lights, hitches, tires, and bearings; loading, balancing, and towing a trailer; towing (and backing) a trailer; boat launching and retrieving; boat storage and theft protection; launching, retrieving and storing a PWC.

Hunting and Fishing, Water-skiing and River Boating - Carrying hunting gear and weapons in a boat; fishing from a boat; water-skiing safety guidelines and hand signals; water-skiing with a PWC; navigating rivers, and other boating tips.

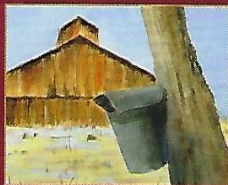
